Washington State Sexual Offense Bench Guide for Judges

The Washington Coalition of Sexual Assault Programs (WCSAP) recently had the privilege of working with the Washington State Supreme Court Gender and Justice Commission, judicial officers, and the King County Sexual Assault Resource Center (KCSARC) to develop the first edition of the **Sexual Offense Bench Guide for Judges.**

The purpose of a bench guide is to educate judicial officers (judges or commissioners) who decide particular types of cases about the law, and also about the underlying issues that may pertain to the case. In the case of a bench guide focused on sexual assault cases, the purpose is to educate judicial officers about sexual offenses specific to the state they preside in, and about the dynamics of sexual violence in general.

The Gender and Justice Commission initiated the development of a sexual assault bench guide for Washington to support "judicial officers in providing a consistent and unbiased response to...sexual violence." Chief Justice Barbara A. Madsen, in her introductory letter to the guide, wrote that:

This bench guide addresses the many facets of court proceedings in sexual violence cases and provides a framework to address the serious impact of sexual violence on victims and the rehabilitative value of holding offenders accountable for their actions.

Washington is one of only a handful of states that have a bench guide that focuses on sexual assault cases. This first edition of the bench guide focuses on criminal sexual offenses and the Sexual Assault Protection Order (SAPO). It also includes an appendix focused on the impact of sexual violence on the LGBTQ community. WCSAP hopes to be a part of any future editions of the Sexual Offense Bench Guide that might expand the focus to issues of sexual violence in civil matters and the impact of sexual violence on other specific populations and communities.

The following is a list of the bench guide chapters, with a brief summary of the information covered in each chapter that may be helpful to advocates. A link to the guide and to each full chapter is also included.

Advocate Tips for Using the Bench Guide

- Talk with court personnel and/or judicial officers in your county. Ensure that the judicial officers who handle sexual offense cases and SAPO cases have a copy of the bench guide or know how to access it online.
- Print out the two-page Sexual Assault Protection Order Hearing Bench Card and provide it to:
 - Judicial officers who handle SAPO cases.
 - \circ Attorneys in your county who represent clients in SAPO cases.
 - Legal advocates who accompany survivors to SAPO hearings so

they are familiar with these rules and statutes.

- Each survivor who has an upcoming SAPO hearing so they know what to expect and are better prepared to respond if an issue arises during their hearing.
- Provide a copy of the *Judges Tell* article to the members of any multidisciplinary teams that your agency participates in; lead a discussion on how the legal system responds to victims of sexual assault.
- Use the information in Chapter 1: Understanding Sexual Violence to help you explain the dynamics of sexual violence at trainings or community presentations.
- Use the information in Chapter 1 to educate law enforcement officers in your community about how their response to victims can help them or further victimize them.
